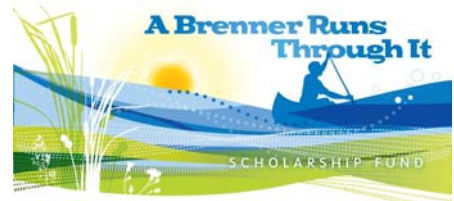

**DESCRIPTION:**

The **Brenner Runs Through It Scholarship Endowment Fund** will be established as a permanent, named endowment fund of the McGaw YMCA, Inc once it reaches a minimum of \$50,000 from all sources within five years of the date the McGaw YMCA accepts the initial Pledge Agreement towards this fund. If the fund does not reach \$50,000 within the above stated timeframe, the existing funds restricted to the **Brenner Runs Through It Scholarship Fund** will be used to establish a board designated fund to generate annual scholarship funds for campers in the Camp Echo Tripping Program. The principal of the **Brenner Scholarship Endowment** will be invested and managed in accordance with the Endowment and Investment policies established by the McGaw YMCA Board of Directors with the understanding that the principal is to remain invested and managed in perpetuity.

Once the named fund is established with a minimum of \$50,000, the interest and earnings accrued annually from the **Brenner Runs Through It Scholarship Fund** shall be restricted for use to provide scholarship to participants in the Camp Echo Tripping Program. The scholarship recipients will be selected on the basis of financial need, and determination of recipients will be administered by McGaw YMCA and Camp Echo staff.

Others wishing to support the purpose of this fund at their option and discretion may make future contributions.

**PUBLICATION AND COMMUNICATION:**

The McGaw YMCA and its Camp Echo program reserve the right to publicize this gift and recognize donors accordingly. Initial donors to set up the fund and reach the \$50,000 amount will be acknowledged as Charter Donors of the fund. McGaw YMCA Camp Echo administration will communicate annually with \_\_\_\_\_ regarding the status of this Fund.
